The April Meeting of Ashland Betterment Coalition was held on Monday, April 8, 2024 at 7 p.m. at Ashland City Hall with Izzy Smith, Debbie Mudd, Lizzie Benke (through ZOOM), Jessica Ward, Tara Blue, Sharon Adams and two guests, Dorise Slinker, Mayor and Rachel Beal.

Izzy reported she recently read through our By-Laws and we can have 9 Board Members and currently have 6.

Izzy moved forward to March minutes were reviewed by Izzy and approved.

Izzy gave the Treasurer's Report as follows:

Beginning March Balance: \$10,766.13 Deposits: \$1,804.78 Withdrawals: \$600.00 Ending Balance: \$11,970.91

Of the ending \$11,970.91 balance, \$3,512.86 remains of the \$5,000 received from the City of Ashland in early 2023 for administration costs, leaving a net of \$8,458.05 from contributions and fundraising. There is currently one check outstanding for \$260.00. Treasurer's Report was motioned and approved.

Guest Speaker, Justin Aldred, Boone County District 1 Commissioner will be our guest speaker at our May Meeting since we cancelled our April 1, 2024 meeting due to weather.

SOBOCO Chamber of Commerce Expo is scheduled for Friday, May 10th and we will be represented with an informational table. There will be a "Best Booth" will seek more information about that and decide if we want to participate. There will be 3 shifts throughout the day 9-11 a.m., 11-1 p.m., 1-3 p.m. Debbie Mudd will do the 9 a.m.- 11 a.m., Sharon Adams will do 11a.m.-1 p.m. and Izzy will do 1 p.m.-3 p.m. There is a"kick off" event the evening before and we can decorate and set up our booth at that time. Planter Updates:
